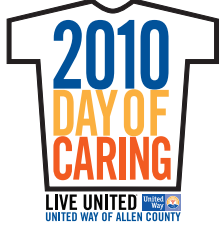

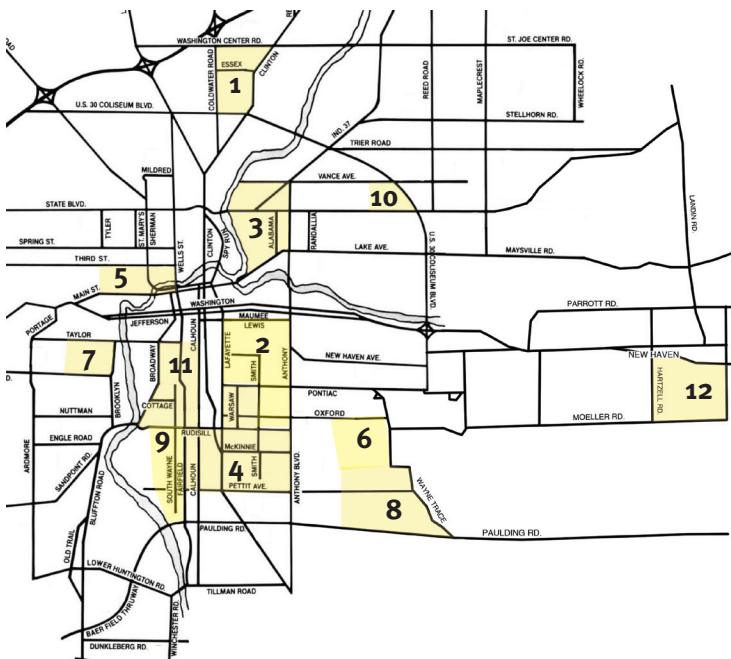
# United Way of Allen County 2010 Day of Caring Team Application
