## 2021-2022 Program Service Accomplishments

### **Agency Investments**

Provided \$1.73M to 30 agencies

#### **Persistence Pays Off**

- Provided 289 financial literacy lessons to students
- Provided over \$59,000 in emergency financial assistance to students
- 88% of students persisted (completed a certificate, graduated with an associate or bachelor's degree, or reenrolled in the fall semester to continue their education)

#### **Day of Caring**

- 1,394 volunteers from 78 teams
- Completed 65 projects
- Cost of volunteer hours was \$250,502

#### **Volunteer Income Tax Assistance**

- Completed 2,394 taxes returns
- \$3.1M in tax refunds returned to the community
- \$524,480 in tax preparation fees saved

#### **Kindergarten Countdown**

- 114 students enrolled
- Pre-literacy skills increased 22%
- Basic math skills increased 10%
