## **ENERGY ASSISTANCE**

The Energy Assistance Program (EAP) helps pay a portion of your heating bill.

Although our offices are closed due to COVID-19 concerns, we are able to serve you through our phones, email, and website. We are still accepting EAP applications for the 2019-2020 program year. In addition, if you have recently lost your job, or been laid-off and have no funds to pay your heating and/or electric bill, please apply now. You can submit all of your EAP Application documentation electronically through our website or by email to gethelp@mybrightpoint.org or fax to (844) 510-5775 or drop off at drop boxes located outside our offices.

## Eligibility:

Energy Assistance benefits are available to households with a combined annual income at or below 60% of State Median income or 150% of the current poverty level, whichever is higher. (Poverty levels are determined by the Office of Management and Budget.)

If utility service is NOT disconnected, you may submit the Energy Assistance Program web/mail-in application with the following documentation. If you are disconnected, please call our office.

- The State-issued photo ID for the applicant
- The completed application with all questions answered and the last page signed and dated
- Copies of Social Sercurity cards for all members one year or older
- A copy of proof of income recieved in the last 3 full calendar months for each household members age 18 or over
- If you paid child support, please send proof of child support payments
- A copy of your current heating bill and electric bill
- If you are a homeowner, a copy of your property taxes, mortgage statement, homeowner insurance or deed
- If you rent your home and electric and/or heating are included in your rent, please include a landlord affidavit completed and signed by your landlord or an authorized designee
- Households calming Veteran status must provide a DD\_214 or Veteran's Administration Identification card

The EAP Application and all required documentation must be submitted to the Brightpoint office by May 15, 2020.
