KINDERGARTEN COUNTDOWN:

KINDERGARTEN COUNTDOWN COMPLETED ITS NINTH YEAR WHERE 97 CHILDREN ATTENDED CLASSES IN THE SCHOOLS THEY WILL BE ATTENDING IN THE FALL. THE PROGRAM OPERATES IN TWO PUBLIC SCHOOL DISTRICTS AND EMPHASIZES CLASSROOM SKILLS LIKE RAISING HANDS AND LINING UP QUIETLY AS WELL AS STRENGTHENING THE LITERACY SKILLS THAT ARE NECESSARY TO LEARN TO READ. THIS YEAR'S STUDENTS SHOWED A 18 PERCENT INCREASE IN BASIC LITERACY SKILLS AND A 16 PERCENT INCREASE IN SOCIAL EMOTIONAL SCORES FROM THE ASSESSMENTS COMPLETED AT THE BEGINNING AND END OF THE FOUR-WEEK PROGRAM. THERE WAS A 44 PERCENT INCREASE IN THE NUMBER STUDENTS ABLE TO WRITE THEIR NAMES.
